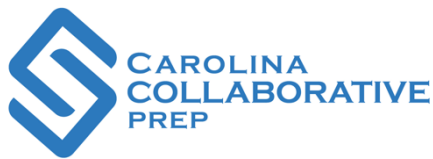


Guidelines for CCP Scholarship

- **This is an application for scholarships based on financial need**
- Currently, scholarship money is only available to new students not previously enrolled at Carolina Collaborative Prep (CCP)
- Receiving a scholarship does not guarantee that you will receive a scholarship in subsequent years
- Most recent tax return must be submitted with your application (just the Form 1040)
- Applications will be reviewed as they are received, and determination will be based only on scholarship money that is still available
- Incomplete applications will not be considered for review
- No CCP Board Members are eligible to request financial aid
- All applications remain anonymous to the CCP Board Scholarship Committee Members
- Scholarship determinations and dollar amounts are made by the CCP Board Scholarship Committee Members
- At this time, only partial scholarships are funded
